1970 - CONSULTATION ON PLANNING APPLICATIONS NOTIFIED BY WEYMOUTH & PORTLAND BOROUGH COUNCIL

Having considered each application in turn, the Advisory Committee agreed the following observations:-

- a) 12/285/FUL HM YOI The Grove Erection of a single-storey modular Offender Management Unit building within the existing secure perimeter **NO OBJECTION**
- b) 12/322/FUL Weymouth & Portland National Sailing Academy, Hamm Beach Road Construction of a new above ground water tank with integrated booster pumps and control equipment within a GRP enclosure **NO OBJECTION**
- c) 12/324/FUL HM YOI The Grove Erection of one 210 sq.m polytunnel adjacent to the Beaufort House block

NO OBJECTION

d) 12/329/BHUTS – Hut 14, Field 761, access to Fields 737, 739, 760, 761 and 765, Portland Bill – Extension of temporary planning permission on existing beach hut

NO OBJECTION

e) 12/345/FUL – Land south and west of Mulberry Avenue – Temporary use of land as car and coach parking

NO OBJECTION, subject to temporary permission for one year

1971 - PLANNING CONTRAVENTION ISSUES

Cllr. Collinge asked what had happened to the arrangement that a home for old people would be built as part of the Tesco development. The Planning Officer undertook to pursue this with the owner of the site, the developer and Borough Councillors.

Cllr. Hughes drew attention to concrete steps which had lately been put in place on Crown land by Jacob's Well. Had permission been sought? The Planning Officer agreed to investigate.

1972 - DRY STONE WALLS

The Planning Officer will continue to seek advice on the draft Council policy from members of his department. Meanwhile it was noted that the draft Local Development Framework will go out to public consultation on 1st June for six weeks.

Regarding funding for repairs to stone walls it was stated that such funding was more likely to be forthcoming where the volunteer group involved had a plan and a history of doing this kind of work. Suggestions were made for several possible funding sources.

1975 - PLANNING APPLICATIONS BILL

The Council had received an e-mail requesting support for a Planning Applications (Appeals by Town and Parish Councils) Bill, shortly to be brought before Parliament. The Bill apparently conforms to official NALC policy and gives parish councils the right to appeal against the granting of planning permission where the local council has advised against acceptance and that advice has been ignored. Councils have been asked to write to named MPs urging them to adopt this Bill.
