1778 – CONSULTATION ON PLANNING APPLICATIONS NOTIFIED BY WEYMOUTH & PORTLAND BOROUGH COUNCIL

Having considered each application in turn, the Advisory Committee agreed the following observations:-

a) 10/615/BHUTS – Hut 31, Field 765, Access to Fields 737, 739, 760, 761 and 765, Portland Bill

b) 10/618/FUL – 10 Old Coastguard Cottages, Portland Bill – Erect summerhouse

OBJECTION, on the grounds that the proposed building is oversize, of poor appearance in context and sets an unfortunate precedent

c) 10/620/FUL – Works buildings, north end of Perryfield Works complex, Pennsylvania Road – Erect six dwellings

NO OBJECTION, subject to all six units being offered as affordable homes and to the comments of the highways and mineral officers, Natural England and the Environment Agency

d) 10/629/FUL – Pitthays Cottage, Old Hill – Erect conservatory to side elevation

i) 10/522/COU - Lime Kiln, 2 Easton Lane - Change of use of part of property to A1 class shop and workshop, and create one car parking space (Revised submission)

OBJECTION, on the grounds that there is a lack of parking for an A1 class shop in this particular location
