2246 – CONSULTATION ON PLANNING APPLICATIONS NOTIFIED BY DORSET COUNTY COUNCIL

14/041/DCC – Disused railway cutting land south of Park Road – Retention of fill material etc.

OBJECTION, the Clerk was asked to write again to the County, restating the content of the Council's first letter regarding the infill and asking for the area to be reinstated. He was also asked to state that the quarry waste used for infill should have been put back in the proper place as backfill. The Committee wishes the route to remain a claimed Right of Way and not become a permissive footpath in a revised arrangement.

Cllr. Lees requested details of when the planning application will go to the County Planning Committee.

2247 - NEIGHBOURHOOD PLAN

Cllr. Matthews reported that the Working Group is drawing together a "high-level" report from the recent consultation responses so that the public can understand where the consultation process is leading. He also answered questions about the Plan from members of the public present.
