2419 - PLANNING CONTRAVENTION ISSUES

Cllr. Cocking reported the removal of hedges and other landscape alterations in the vicinity of Cheyne House in spite of a request to stop from the County. The Planning Officer undertook to investigate.

Cllr. Flack asked about the progress of discontinuance notices for advertisement hoardings in Fortuneswell. The Planning Officer agreed to check.

Cllr. Lees spoke regarding complaints of dust in the atmosphere around Wakeham and the Tesco's site. She said that the stone companies were no longer carrying out wheel washes to their vehicles nor sheeting the contents of their lorries.
