2504 – PUBLIC PARTICIPATION

Mr Matthews requested permission to speak on Agenda Item 11 – Road Schemes.

Cllr. Wild voiced the concern of a Mrs Gillespie who had raised it on a visit to the Offices. It involved parking alongside a protruding grass verge along Wakeham in the vicinity of Bumpers Lane, which was narrowing the carriageway to one lane at that point. **RESOLVED** – that the Council write to Dorset Highways requesting double yellow lines alongside the grass verge.

2505 – NEIGHBOURHOOD PLAN

Mr Matthews spoke to his written report on the latest Local Plan consultation. The Councils Partnership had produced an analysis of potential housing development sites on the Island in order to meet government requirements. Three main areas had been identified. Mr Matthews wondered whether the Neighbourhood Plan might provide an alternative. The detailed study by Aecom was still awaited. He felt that employment land and redundant public land should also be taken into consideration.

Cllr. Nowak was concerned that the Local Plan was amalgamating village settlements, such as Easton with Weston. The report was good in taking account of the Island's many SSSI's and the quarry park strategy.

It was agreed that Cllr. Nowak and Mr Matthews should draft a response to the questions in the consultation, referring to items in the Neighbourhood Plan.

2506 – CONSULTATION ON PLANNING APPLICATIONS NOTIFIED BY WEYMOUTH & PORTLAND BOROUGH COUNCIL

Having considered each application in turn, the Advisory Committee agreed the following observations:-

a) 16/697/FUL – Hut 27, Field 760, Access to Fields 737, 739, 760, 761 and 765, Portland Bill – Retention of existing beach hut

b) 16/757/FUL – 26 Killicks Hill – Extension to existing raised platform to front of property (retrospective)

NO OBJECTION

c) 16/766/ADV – Co-op Store, 36-37 Easton Square, Portland – Install three illuminated fascias, one non-illuminated fascia, one internal illuminated projector and two non-illuminated, wall-mounted, aluminium panels

d) 16/715/FUL – 25 Clarence Road – Erect single-storey extension (additional item)

NO OBJECTION, subject to the comments of the neighbouring householders

2507 – ENLARGED BEACH HUT REPLACEMENTS

Members agreed that the Council should request site plans of all beach huts on the Island, at the Bill, Church Ope and West Weares together with details of the land ownership at the sites concerned.

2508 – PLANNING CONTRAVENTION ISSUES

None were raised.

2509 – CONSULTATION ON PLANNING APPLICATIONS NOTIFIED BY DORSET COUNTY COUNCIL

16/818/NOTS – Coombefield Quarry – Extraction of Portland Stone by Underground Quarrying Methods

NO OBJECTION, subject to the results of the appropriate environmental assessments.

It was noted that the Chairman will arrange a site visit for members to the mine at Perryfield.

2510 – ROAD SCHEMES – HORSE CAUTION SIGNS

It was agreed to request a highways officer to speak at a meeting either of the Town Council or Planning Committee on various issues of concern, which would include road signage on the Island.
